

# INSTRUCTIONS FOR USE

The footwear is classified as Category I personal protective equipment as per Regulation EU 2016/425 and meets the requirements of PN-EN ISO 20347:2012.

## READ THIS INSTRUCTION CAREFULLY BEFORE USING THE PRODUCT

**Category I includes the protection against the following minimal risks only:**

- a) superficial mechanical injuries;
- b) contact with weak cleaning agents or prolonged contact with water;
- c) contact with hot surfaces the temperature of which does not exceed 50°C;
- d) eyesight impairment as a result of exposure to sunlight (other than through sun observation);
- e) non-extreme weather conditions.

### Storage:

Store in rooms where humidity ranges from 45% to 65%, protect against moisture, soiling, and direct sunlight, keep away from heat sources. The footwear storage period depends on the conditions of use and the methods of preservation – recommended no longer than 12 months. Before each use, check whether the footwear is suitable for further use. **Period of durability:** due to the variable nature of external conditions (temperature, humidity, sunlight etc.) as well as the method and intensity of footwear use, the period of durability can be assessed based on the product wear and tear.

### Footwear use and preservation

- The footwear needs to be preserved and cleaned. For external and internal soiling, use a cloth moistened with water and commonly accessible cleaning and disinfecting agents. Velour leathers need to be cleaned with a special dry brush.
- Undo the buckle before putting the footwear on and before taking it off.
- Footwear zips, clips, and buckles need to be done and undone without using excessive force.
- Throughout the use of the footwear, creases may occur as a natural property of leather.
- Avoid exposing the footwear to moisture. In case of overwetting, dry in a well-ventilated place, away from heat sources, at room temperature. Insert shoe trees into the footwear or fill it with paper in order to keep their right shape. Do not use hair-dryers, radiators, heaters, etc. to dry the footwear.
- The manufacturer shall not be responsible for the influence of chemical and cleaning products on the soles and the uppers of the footwear.
- Do not use self-polishing agents to preserve the footwear.
- If used every day for many hours, do not put the footwear on bare feet. Replace insoles as they are becoming worn-out.
- Do not wash, as it reduces the leather elasticity, leads to cracking, and weakens the seams.
- White materials used for making the footwear may go yellow over time – this does not change its usability properties.
- Failure to comply with the above guidelines voids the warranty.

**NOTE! Footwear with leather lining or with leather upper without any lining may stain clothing. We do not accept returns on such grounds.**

### Terms and conditions of warranty and complaints

- The footwear is subject to a 24-month warranty if purchased for personal use.
- The footwear is subject to a 12-month warranty if purchased for professional or company use.
- The warranty covers latent defects of the footwear attributable to the manufacturer.
- Manifest defects visible at the time of purchase.
- Faster wear and tear of the footwear may be caused by the intensity of use, failure to comply with the instructions for use or lack of preservation measures.
- Returns are accepted only if the footwear is clean, dry, and not worn-out.
- Pre-sales complaints are accepted only if the footwear has not been worn, is clean, and shows no signs of use.
- Complaints regarding worn-out, soiled, and mechanically damaged footwear will not be examined.
- Complaints must be lodged immediately after a footwear defect becomes visible.
- A complaint must be accompanied by a proof of purchase (a cash register receipt or an invoice) and a complaint form available on the website: [www.medibut.com.pl](http://www.medibut.com.pl)
- The footwear must be sent to the manufacturer at the expense of the complaining party; however, the manufacturer sends back the footwear at their own expense.

### The warranty does not cover:

- Size mismatch.
- Footwear comfort of use.
- Furthermore, the warranty does not cover mechanical damage (of e.g. zips, buckles, soles), abrasions, seam wear and tear, and damage arising from size mismatch or misuse, defects visible at the time of purchase, soiling, stains, damp patches, footwear that is soiled, worn-out, neglected, wet, and not preserved, shallow crevices along the gluing edge of the soles, as well as incorrect preservation. The warranty neither covers damage arising from natural wear and tear (of e.g. soles, lining, etc.).
- Material deterioration resulting from the impact of cleaning / disinfecting agents not appropriate for cleaning footwear.
- Footwear soaking.
- Differences in the colour and texture of leather and creases occurring during use and arising from the natural properties of leather and leather-like materials.

### Anti-skid properties of CE-marked professional footwear

- Footwear belonging to this group has anti-skid properties designated with the SRB symbol – in order to minimize the risk of slipping, you need to match as best as possible the footwear and sole model to the conditions present where the footwear is used.
- The anti-skid properties of the footwear are affected by such factors as sole soiling or floor contamination, therefore you need to keep the soles of the footwear clean.
- Anti-skid properties of the soles can wear off over time due to the natural wear and tear of the soles or the impact of chemical substances.

### PROFESSIONAL FOOTWEAR LABELING

The type of professional footwear should be chosen after having analysed the threats arising from the work performed and the place of use. See examples of professional footwear labelling with description below.

OB. – essential requirements for professional footwear

E – heel shock absorption

A – anti-static footwear

C – conductive footwear

WRU – water resistant upper

SRA – slip resistance on wetted surfaces – ceramic ; SRB – steel, and SRC – both

FO – sole resistance to hydrocarbons
